NOTICE IS HEREBY GIVEN that, pursuant to Sections 4.13(f) and (g) of the Indenture, dated as of June 16, 2021 (as amended or supplemented from time to time, the “Indenture”), amongst others, GCL New Energy Holdings Limited (the “Company”), the Subsidiary Guarantors listed on Schedule I thereto and The Bank of New York Mellon, London Branch, as Trustee, entered into in connection with the Company’s issuance of 10.00% Senior Notes Due 2024 (the “Notes”), the Company will use US\$76,900,000, being the Remaining Proceeds (as defined in the Indenture) from the Significant Asset Sale Offer (as defined in the Indenture), to redeem an equivalent amount of Notes on January 25, 2022 (the “Redemption Date”) at a redemption price equal to 100.00% of the principal amount thereof, plus accrued and unpaid interest to (but not including), the Redemption Date (the “Redemption Price”).

The amount of accrued and unpaid interest with respect to the Notes to (but not including) the Redemption Date will be approximately US\$0.0608 on each US\$1 of Notes. The Redemption Price for all outstanding Notes in the principal amount of US\$76,900,000 to be redeemed on the Redemption Date will be the aggregate amount of US\$81,578,083.3300, or approximately US\$1.0608 for each US\$1 of Notes.

On the Redemption Date, the Redemption Price will become due and payable on each Note to be redeemed and, unless the Company defaults in the payment of the Redemption Price, interest on the Notes will cease to accrue from and including the Redemption Date.

The Notes for redemption will be selected in accordance with the pro rata drawing procedures of Euroclear and Clearstream. Payment of the Redemption Price and surrender of the Notes for redemption will be made through the facilities of Euroclear and Clearstream. Payment of the Redemption Price (together with accrued and unpaid interest) of the Notes will be made on the Redemption Date and interest on the Redeemed Notes shall cease to accrue on and after the Redemption Date.

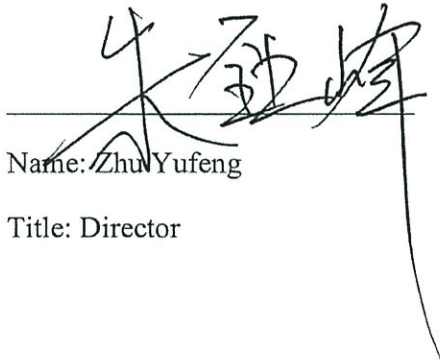
