Reference is hereby made to the amended and restated trust deed dated 1 August 2023 in respect of the Notes (as amended or supplemented from time to time, the “**Trust Deed**”) between the Issuer, the Guarantors and China Construction Bank (Asia) Corporation Limited (中國建設銀行(亞洲)股份有限公司) as the Trustee. Capitalised terms used but not defined herein shall have the meanings given to them in the Trust Deed.

The Company announces today that, in accordance with Condition 4(b) (*PIK Interest Election*) of the Trust Deed, the Company intends to pay PIK Interest in an amount of U.S.\$29,820,000 (calculated at the PIK Interest Rate of 6.00 per cent. per annum on the U.S.\$497,000,000 in outstanding principal amount of the Notes) for the Interest Period from and including 22 June 2023 to but excluding 22 June 2024. No Cash Interest will be paid for such Interest Period. Such PIK Interest will be paid on 24 June 2024 (being the first business day (as defined in Condition 6(d) (*Payments on business days*)) after the Interest Payment Date falling on 22 June 2024) and shall constitute principal amount of the Notes from and including 22 June 2024, increasing the outstanding principal amount of the Notes to U.S.\$526,820,000.
